Welcome to Career Technical Education (CTE)! In accordance with Idaho Code §33-1614, this board-approved professional development course prepares Idaho teachers to deliver the First Steps Standards in newly required career exploration courses for seventh or eighth grade students beginning Fall 2023.

The First Steps Standards Professional Development Course is a 15-hour, three-week course with three sequential modules delivered online through Canvas. Zoom meeting(s) are required during week 3.

Choose a cohort and register now!


Cohort 18 is the last opportunity to complete course before second semester.

- 3. Taught 8th Grade Career Exploration for IDLA between Fall 2020-May 2023
- 4. Upload clear evidence of prior learning, **per module**, in 'Optional: Allowance 4 Evidence Submissions' under Module 1 by <u>Wednesday at 11:59 pm (MT) of Week 1.</u> The evidence required is:
 - Module 1 Unofficial transcript of completion of Foundations of CTE course
 - Module 2 Unofficial transcript or certificate of completion of non-credit bearing Career Guidance/Development course
 - Module 3 Three pieces:
 - 21-22 or 22-23 course syllabus identifying the instruction of each of the First Steps Standards
 - AND certificate of completion of professional development related to implicit bias
 - AND submission of Parts 1 and 2 of the Capstone Project, as required

Documentation of Completion through SkillStack®

Progress toward and course completion is documented through Idaho's microcredential platform, SkillStack®. Sub-badges are awarded upon completion of each module and stack to a First Steps badge upon completion of the course. Participants will have access to their badges through SkillStack®.

Optional Professional Development Credit

One credit available through University of Idaho for \$55.00. One additional credit available for submission of a reflective essay following the course for and additional \$55.00. More information will be shared in the course.
