



# Perkins V

Public Comment Period: State Determined Performance Levels (SDPLs)

## Overview

Idaho Division of Career Technical Education (IDCTE) is requesting comments regarding State Determined Performance Levels (SDPLs). The comment period is open for 30 days and comments should be sent to [stakeholderinput@cte.idaho.gov](mailto:stakeholderinput@cte.idaho.gov).

## Background

Under Perkins V:

- SDPLs are required as part of the State Plan submission process and levels will advance the State Plan goals.
- Once approved, the SDPLs will be in effect for the next four school years (through 2028). **The data table shows this as Proposed Targets.**
- Perkins V requires the SDPLs to be higher than the actual performance average of the 2 most recently completed program years, except in the case of unanticipated circumstances that require revisions. **The data tables show this as the SDPL Floor.**
- Trend data includes performance data from the past three school years. **The data table shows this as Actual Statewide Performance.**

IDCTE is also seeking public comment on a [revised State Plan](#) for the next four years. The State Plan identifies the performance indicators for secondary and postsecondary. If recipients fall below 90% of the SDPL, an improvement plan may be required ([Section 123](#)).
